3. Approved coaches are expected to promote and support the use of the TFSC ice time (Club sessions).
4. Approved coaches are expected to have their skaters participate in our exhibitions, shows, and competitions. Coaches themselves are expected to personally participate and support our exhibitions, shows, and competitions.
5. Approved coaches are expected on the ice to bare the responsibility of a positive training environment and the safety of ALL skaters.
6. Newly approved coaches will be reviewed at the conclusion of a probationary period of 6 months by the board.
